### ALMONT TOWNSHIP PLANNING COMMISSION REGULAR MEETING

OCTOBER 8, 2014

The regular meeting of the Almont Township Planning Commission was called to order at 7:00 P.M. by Chair Steve Francis at the Almont Township /Village Hall, 817/819 N. Main Street, Almont, Michigan 48003. Roll call was taken.

**CORRESPONDENCE:** Presented by Chairman Francis.

**MINUTES: MOVED BY STREETER AND SUPPORTED BY HUNTER TO RECEIVE THE MINUTES FROM SEPTEMBER 10, 2014 AS PRESENTED. MOTION CARRIED.**

**NEW BUSINESS:** Sign Application – 4632 Van Dyke

Mr. Pete Rayl of North Bound Auto Repair and AP Gunworks noted that he would like to replace his existing sign and erect a new LED sign. The new sign would be moved more to the north and closer to the R.O.W. than his existing sign.

Upon review of the Sign Ordinance 2.21 it was noted by the Commissioners that the size and placement of the sign fell well within the allowable guidelines for newly erected signs. Mr. Rayl was asked to reread the sign ordinance carefully to make sure that the LED portion of the sign did not exceed the intensity levels for both daytime and nighttime.

Sign Application – 4632 Van Dyke Continued:

**OLD BUSINESS:** Sign Ordinance 2.21 - Creative /Special Event Signs

Discussion followed on what constitutes a “creative sign”. Upon reviewing the definition of “signs” in section 2.21.M. Commissioners felt that instead of creating a new section, it may be better to amend the definition of signs so that business owners would be allowed to have “creative displays” so long as no wording or logos were attached to the display. Commissioners agreed to instruct Mr. Piggott to research said possibility and report back to the Planning Commission at the November 12, 2014.

Commissioners again reaffirmed their position on enforcing the current sign ordinance as it is, without making any notable changes.
