MOVED BY SWEERS, SUPPORTED BY STROUP TO APPROVE CONSENT AGENDA WHICH CONSISTS OF THE REGULAR MEETING MINUTES OF SEPTEMBER 13, 2010, TOWNSHIP PAYROLL AND MONTHLY BILLS IN THE AMOUNT OF \$112,560.84 AND ACKNOWLEDGE THE TREASURER'S REPORT. CARRIED.

MOVED BY STROUP, SUPPORTED BY HOFFNER TO APPROVE THE RESOLUTION TO IMPOSE A 3% LATE PENALTY ON PROPERTY TAXES AND DIRECT THE TREASURER TO COLLECT THIS PENALTY PLUS THE 1% INTEREST OF ALL TAXES PAID BETWEEN FEBRUARY 14 AND BEFORE MARCH 1 BEGINNING IN 2011. ROLL CALL VOTE: SWEERS-YES, ESCHENBURG-NO, MOORE-NO, STROUP-YES, RAYL-NO, HOFFNER-YES, BOWMAN-YES. CARRIED

MOVED BY ESCHENBURG, SUPPORTED BY SWEERS TO APPROVE SCOTT'S LAWN SERVICE AS THE CONTRACTOR TO REMOVE SNOW AT THE FIRE HALL. CARRIED.


MOVED BY ESCHENBURG, SUPPORTED BY MOORE TO HAVE ANDY
