ALMONT TOWNSHIP BOARD
REGULAR MEETING MINUTES
APRIL 12, 2021

Meeting called to order by Supervisor at 7:00 p.m. at 819 N. Main St., Almont, MI. Members present were Supervisor Bowman, Clerk Hoffner, Treasurer Kudsin, and Trustees Streeter, Groesbeck, Eschenburg, and Dodge. Pledge of Allegiance was said. Agenda accepted as presented.

MOVED BY STREETER, SUPPORTED BY HOFFNER TO APPROVE INCREASING THE BUDGET FOR STREETLIGHTS FROM \$8,000 TO \$11,000 AND ELECTIONS FROM \$11,658 TO \$13,000 WITH THE MONIES COMING FROM CONTINGENCIES. CARRIED.

MOVED BY HOFFNER, SUPPORTED BY KUDSIN TO APPROVE CONSENT AGENDA WHICH CONSISTS OF THE REGULAR MEETING MINUTES OF MARCH 8, 2021, TOWNSHIP PAYROLL AND MONTHLY BILLS IN THE AMOUNT OF \$76,882.25 AND ACKNOWLEDGE THE TREASURER'S REPORT. CARRIED.

NEW BUSINESS: MOVED BY KUDSIN, SUPPORTED BY STREETER TO APPROVE THE METRO ACT PERMIT SUBMITTED BY COMCAST AND AUTHORIZE THE SUPERVISOR TO SIGN THE DOCUMENTS ON BEHALF OF ALMONT TOWNSHIP. CARRIED.

MOVED BY KUDSIN, SUPPORTED BY DODGE TO APPROVE THE ROAD PROJECT FOR 3000 TON OF GRAVEL TO BE PLACED ON VARIOUS SPOTS IN THE TOWNSHIP AT A COST OF \$38,400. CARRIED.

MOVED BY STREETER, SUPPORTED BY HOFFNER TO APPROVE THE INSTALLATION OF A NON-MOTORIZED PATHWAY ALONG KIDDER ROAD FROM THE VILLAGE LIMITS NORTH TO ORCHARD PRIMARY SCHOOL PER ATTACHED DRAWING AT A COST NOT TO EXCEED \$150,000 WITH \$90,000 COMING FROM THE ROAD COMMISSION. COST TO TOWNSHIP, NOT TO EXCEED \$60,000. CARRIED.

MOVED BY KUDSIN, SUPPORTED BY DODGE TO APPROVE THE PAVING PROJECT OF TUBRING ROAD FROM HOWLAND TO VANDYKE PER LCRC CONSTRUCTION ESTIMATE, AT A COST NOT TO EXCEED \$214,000. CARRIED.

MOVED BY DODGE, SUPPORTED BY KUDISN TO AWARD THE LAWN MOWING CONTRACT FOR 3 YEARS FOR THE FIRE HALL TO YARD SERVICES, AT \$75 PER CUT FOR 2021, \$80 PER CUT FOR YEARS 2022 AND 2023 AND THE BALL FIELDS TO JOSH'S OUTDOOR SERVICES FOR \$175 PER CUT FOR YEARS 2021 THRU 2023. CARRIED.

MOVED BY STREETER, SUPPORTED BY KUDSIN TO APPROVE INCREASING THE SITE PLAN APPROVAL FEE FROM \$2,100 TO \$3,100 AND THE SPECIAL LAND USE FEE FROM \$600 TO \$1,000. CARRIED.
