MOVED BY STREETER, SUPPORTED BY HOFFNER TO APPROVE CONSENT AGENDA WHICH CONSISTS OF THE REGULAR MEETING MINUTES OF OCTOBER 12, 2020 AND TOWNSHIP PAYROLL AND MONTHLY BILLS IN THE AMOUNT OF \$74,021.59. CARRIED.

MOVED BY HOFFNER, SUPPORTED STROUP TO APPROVE THE RECOMMENDATION OF THE PLANNING COMMISSION TO AMEND ARTICLE 2 SECTION 2.33 AND ARTICLE 14 DEFINITIONS, OF THE ZONING ORDINANCE TO NOT PERMIT THE USE OF OVER THE ROAD TRUCK TRAILERS, SHIPPING CONTAINERS AND OTHER ENCLOSED TRAILERS AS PERMANENT ACCESSORY BUILDINGS. ROLL CALL VOTE: STROUP-YES, HOFFNER-YES, STREETER-YES, BOWMAN-YES. MOTION CARRIED.
