MOVED BY HOFFNER, SUPPORTED BY STREETER TO APPROVE THE BUDGET INCREASE OF \$5,000 FOR CEMETERIES FOR A NEW TOTAL OF \$20,000 AND INCREASE THE ZBA BUDGET BY \$370 TO \$2,000 WITH MONIES TO COME FROM CONTINGENCIES. CARRIED.
