NEW BUSINESS: MOVED BY DODGE, SUPPORTED BY HOFFNER TO APPROVE THE CONTRACT FOR ASSESSING SERVICES COMMENCING JULY 1, 2022 THROUGH JUNE 30, 2025 WITH TOM VALENTINE FOR \$43,412.24 AS PRESENTED PLUS A SALARY OF \$4,823.64 PER YEAR FOR THE FIRST YEAR OF THE CONTRACT. CARRIED.
