MOVED BY STREETER, SUPPORTED BY KUDSIN TO APPROVE CONSENT AGENDA WHICH CONSISTS OF THE REGULAR MEETING MINUTES OF APRIL 10, 2023 AND TOWNSHIP PAYROLL AND MONTHLY BILLS IN THE AMOUNT OF \$103,593.61. CARRIED.
